**Year 6 Proposed Residential Visit to Caythorpe Court
Friday 27th June 2025 – Monday 30th June 2025**

Further to our letter dated 13th May 2024 regarding the above proposed residential trip, we are writing to advise that unfortunately, the trip will not be going ahead next year. Despite making some amendments to the booking to reduce the cost, the number of children who signed up for a place was still lower than we anticipated and as a result, it is not viable to run the trip for the whole weekend.

We have, however, been in touch with PGL Caythorpe Court, this time with regards to a possible day trip during the week of 23rd June 2025 or 30th June 2025. Caythorpe Court have advised that a day trip starts at 08:30 and that the children would complete four activities across the day and that they would need to bring a packed lunch. The cost of a day trip starts in the region of £62.50 plus transport costs (TBC).

We are writing, therefore, to ascertain your thoughts on a day trip. Please could you complete the attached form and return it to school by Friday 5th July 2024 at the latest so that a decision can be made.
